This book will function essentially as a prequel to the widely successful *Opening Up Middle English Manuscripts: Literary and Visual Approaches*, written by Kathryn Kerby-Fulton, Maidie Hilmo, and Linda Olson (Cornell University Press, 2012). The period under examination is what is often referred to as "Early Middle English," but our work aims not only to engage the literary and material culture of the years 1100-1350 through the close study of key manuscripts, but also to take into account the cross-cultural and transnational connections of the time. Thus, emphasis will be given not only to manuscripts containing mainly Middle English texts, but also to those that contain Anglo-Norman (the French of England), Latin, Welsh, Irish, and works drawn from other linguistic traditions as these relate to Middle English.

Reading Romance, Refashioning the Soul: The Spiritual Role of a Secular Genre in Late Medieval Britain

In this study, I reshape the research that I performed in my dissertation and add significantly to this through the inclusion of a third section fleshing out the implications of my work on later Middle English manuscripts, namely the Lincoln Thornton Manuscript (Lincoln, Cathedral Library, MS 91) and the Heege Manuscript (National Library of Scotland, MS Advocates 19.3.1).

Monograph Project 2

The Permeability of Offa's Dyke: The Rise of Family Compendia in Late Medieval England and Wales

While the physical, cultural, and linguistic barriers that have separated England and Wales for centuries continue to define their respective academic studies, there is titillating evidence that both late medieval Wales and England shared a similar taste both in the books designed as well as texts consumed. In this study, I will examine the history and contents of several large and important manuscripts—some of which I call "family compendia," a term I have coined—in both England and Wales (for example, the Auchinleck Manuscript, Cotton Nero A.x, and Cotton Galba E.ix as well as the *White Book of Rhydderch* and the *Red Book of Hergest*). I will also address shared histories of textual transmission as well as how each culture used their texts by scrutinizing manuscript design, paratextual features, and reader response.

Though occasionally considered in English studies of *Guy of Warwick*, much that has been reported concerning the fifteenth-century Irish adaptation has been misinformed due to an inattention to the manuscript and Irish scholarship. In this article, I situate *Beathadh Sir Gyi o Bharbhuic* within English literary history and demonstrate the importance of a related text—the *Speculum Gy de Warewyke*—to studies of the Auchinleck Manuscript. - "Owain in the Desert: The Centrality of Penance in the Middle Welsh *Rhamant*." This article examines the Middle Welsh romance of *Owain*, also known as the *Chwedl Iarlles y Ffynnon*, with respect both to the text's manuscript contents as well as the Old French and Middle English versions of the narrative. Target journal: *Cambridge Medieval Celtic Studies*.
- "A Proto-Feminist Text? The Middle English *Storie of Asneth* and the Ideal of Marriage." This article compares the ideal of marriage as presented in the *Storie of Asneth* against contemporary theological thought and everyday practice and also considers the text's manuscript context and its audiences. - "'Or est Amors tornee a fable': Redefining Love in Chrétien de Troyes's Yvain." A familiar idea in monastic literature is that love grows by stages. In Chrétien's work, we can observe that same idea applied in vernacular literature. In this article, I examine the progression of Yvain's characterological development vis-à-vis St. Bernard of Clairvaux's conception of the four degrees of love in *De diligendo Deo*. Target journal: Romance Quarterly or Arthuriana.
- "Romance vs. Hagiography: Converting St. Alexis." This article looks at the adaptations of the St. Alexis legend over time and demonstrates that it becomes a romance. The theoretical question is then posed and considered as to whether romance can do the same kind of work as hagiography. Can romance convert? I thus also necessarily take into account the relationship between this text and the figure of Christina of Markyate. Target journal: *Genre*.
- "Theologizing through Literature: Julian of Norwich's Parable of the Lord and Servant and the Allegory of the Daughters of God." Not often considered a particularly literary text, Julian's thinking in the long version of her *Shewings* betrays a considerable reliance on literary modes of thought, significantly in that her most daring theological proposition is made through allegory, an allegory that bares relation to an ancient tradition of thought going all the way back to Midrashic biblical interpretation. Target journal: *Christianity and Literature*.
- « Le personnage du perroquet et l'importance du langage dans Las novas del papagay ». This article, drawing on important studies in subjectivity but also more recent work on animal studies, explores the role of language vis-à-vis the presentation of this text's primary character, a parrot. I then compare such ideas with other talking animals that we observe in Northern French and Anglo-Norman literature. The focus of the project is on the *Distichs of Cato*, a collection of Latin ethical/moral aphorisms that was used as an educational text throughout the Middle Ages and early modern period and thus exerted a considerable influence on Western intellectual history. The goal is to create an online database that includes a census of all known manuscripts containing the Latin *Distichs* as well as those that contain a number of major commentaries and the abundant translations/adaptations of the text into almost every European language. The finished product will also include a meta-edition of the Latin text along with English translation, critical editions and translations of the most important medieval and Renaissance commentaries, links to manuscript images, histories of transmission (including graphs and charts to illustrate movements and proliferations of texts), and explanatory historical material along with bibliography. My work has involved assisting with the census, attending meetings during which we planned the site, and receiving extensive training necessary to encode our information.

I attended a two-day long workshop, April 14-15, 2016, taught by Julia Flanders and Syd Bauman from Northeastern University and hosted by the Center for Digital Scholarship at the University of Notre Dame, during which we reviewed the basics of HTML, XML, and TEI (Text Encoding Initiative), covered the differences between TEI versus HTML markup, and learned advanced TEI and HTML techniques as well as information regarding available resources. I was then in residence at the Cologne Center for eHumanities at the Universität zu Köln in Germany, May 2-May 30, 2016, where I received further hands-on training in the digital humanities from Dr. Franz Fischer and Apl. Prof. Dr. Patrick Sahle while helping to develop the database and encode the texts.
